Bengeworth Road site update

- Engineering within the shaft is continuing, with the installation of a secondary shaft lining, and shaft dividing wall.
- Temporary works have started for a passage to enable the tunnel boring machine to go through.
- Headhouse works are planned to commence when the shaft works are complete in August.






We are progressing with the brick option and are having discussions on the final designs.

Update on National Grid's substation – next steps

- Ongoing discussions about our substation.
- We plan to submit our designs to Lambeth Council for Prior Approval in June. (*Prior Approval is a formal submission to your local planning authority and the purpose of it is to seek confirmation that specified parts of a development are acceptable, before work can commence.*)
- Once submitted to the Council, they will validate the application and then start their own consultation. We will share details about this in due course.
- The application should be determined within eight weeks, but this depends on whether there are any outstanding queries. We will work with Lambeth Council to resolve any issues.


UK Power Networks: Where we are now






